Bringing on the ADP Health Compliance module

At the time that the ACA was implemented, we had a different benefit provider, and they weren't going to be able to do what we needed for ACA. It turned out that we were able to work with ADP for the benefits eligibility platform and, along with that, ADP introduced the ACA solution to us. ACA was overwhelming back then, and it sounded wonderful to have ADP help us with that. ADP's ACA reporting evolution

Then they'd let us know at the top of the spreadsheet what we were supposed to look at, but back then, we didn't even really know what we were looking at because there was so much information. Now we have a wonderful website to use, and it's so easy. We just trust that everything that needs to get done is getting done. We have monthly calls with ADP, and we work through issues along the way. When it comes time for the reports and forms to go out to the employees, and to be reported to the government, everything is just ready. We really don't have to think very much about it because we've been doing it all year long, so it's just ready. I have tremendous peace of mind knowing that it's done, it's done properly, it's ready to go, and we're not going to miss any of the deadlines.
