Founded in honor of the late Major League Baseball player, Fred Hutchinson Cancer Research Center ("Fred Hutch") in Seattle, Washington, is one of the five top cancer research centers in the country. Fred Hutch houses the nation's first and largest cancer prevention research program, as well as the clinical coordinating center of the Women's Health Initiative and the international headquarters of the HIV Vaccine Trials Network. Together with its teams of world-renowned scientists and humanitarians, Fred Hutch is working to prevent, diagnose and treat cancer, HIV/AIDS and other diseases.

As an independent, nonprofit research center, Fred Hutch operates across five different divisions and currently has 3,500 employees across 12 different states, which can make employment tax filing a complicated process. With that in mind, Steven Holdaway, CPP, payroll manager at Fred Hutch, knew it was critical to find a way to help ensure timely and accurate employment tax filing. We recently spoke to Steven to learn more about his experience using ADP SmartCompliance® to handle Fred Hutch's employment tax filing needs.

On handling tax filing in-house

Previously we did everything in-house, but when we became multi-state, we saw a need to outsource employment tax filing. Employment tax filing in multiple states is a tremendous undertaking. Once you get past one or two states, you would literally need a tax department with dedicated resources just for your employment tax filing. There can be severe financial penalties if things go wrong with your filing, even just being a day or two late with your deposits and returns.

Why ADP

In the beginning, Fred Hutch was strictly in the state of Washington, and since there is no state income tax here, it was relatively straightforward from a tax filing perspective. But after becoming multi-state, we knew we didn't have the expertise in-house or the staffing required to actually have a full employment tax filing department. I had been an ADP client in the past, so I brought that to my supervisor, and we made the decision to outsource our employment tax filing with ADP. We've been with ADP for the past six or seven years now.
