## Sending agency notices through an intuitive interface

I absolutely love the ADP SmartCompliance user interface. It's easy to navigate. I can always find what I'm looking for because it's intuitive and everything makes sense. I can upload any agency notice that I receive to the portal, and ADP takes care of it. ADP reaches out to the agency and completes any research that may be required, and I generally don't have to do a single thing. We save so much time by not having to do much of the research required to resolve any issues.

## No hassle W-2s save time and money

We process over 3,500 W-2s each year because of new hires, terminations and current staff. If we had to complete all of these W-2s in-house, it would be extraordinarily time-consuming, not to mention the cost involved. So that's a huge job that ADP takes off our plates.

We get an ADP W-2 report and a Workday W-2 report which we reconcile to each other as a system of checks and balances, so we ensure the two reports match. Employees have year-over-year access to their W-2s in Workday, and we no longer have to print, stuff and mail them. This results in huge cost and time savings for us as it would easily take my staff and me quite a few days to process them on our own, without being able to do our normal work.

### Biggest bang for our buck

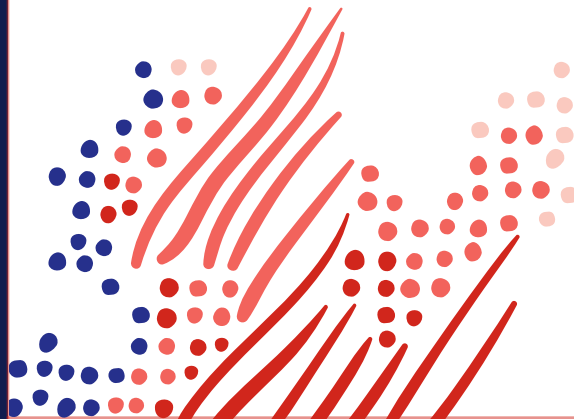
