

International address and tax ID support

ADP Workforce Now supports internationalization for tax identifier, addresses and phone numbers entered and maintained in the system. For tax identifier, it helps ensure the tax identifier is the proper length and has valid characters, based on the tax identifier type to help improve data accuracy, reduce manual work and save time.

Similar to the tax ID, employees' addresses are also validated upon entry. For example, Mexico has a postal code — not a zip code — which is what will be displayed.

Currency conversion

HR practitioners and managers can support multiple currencies within ADP Workforce Now to track information and convert pay rates and pay grades.


Currency can be selected for each pay rate and changed at any time based on the effective date entered by the manager or practitioner. In addition, clients can manage and edit currency conversion rates on their own.

In the Workforce Now talent module, currency fields are available in recruitment for compensation questions, salary fields and requisition costs.
