ADP has received reports regarding fraudulent emails being sent to ADP clients with the following subject line "**ADP 2020 payroll processing guide**" and "**ADP : New payroll processing guide**". These emails instruct the recipient to click on a link in order to learn about a new payroll feature within Workforcenow. The link redirects the user to a phishing ADP login page.



- Forward the email as an attachment to abuse@adp.com, then delete it.
- If you clicked any link or opened an attachment in the email, immediately contact your IT support.
